

The COVID-19 Relief Fund Scholarship is available for both international and domestic students who have incurred financial hardship due to COVID-19.

The COVID-19 Relief Fund awards approximately 50 scholarships covering up to \$1,000 of enrollment fees per student award. This is a one-time award. The scholarship award applies to academic enrollment fees for summer 2020.

The deadline to apply is Friday, May 22, 2020.

Eligibility Criteria

- Must be currently enrolled and a continuing student in a UCLA Extension certificate.
- Students must be registered and have paid certificate candidacy fee.
- GPA of 2.75 or better, in courses already completed in the certificate
- Award is open to international and domestic students who have established candidacy by enrolling in a certificate.
- UCLA and UCLA Extension employees and their family members or dependents are not eligible to apply.

To apply, candidates must submit:

- Completed application form
- 500-1,000 word, typed personal statement in Word or PDF format
- A copy of an unofficial transcript
- Students may only apply one UCLA Extension scholarship per quarter toward course fees.
